

# **CVCF 50/50 Lottery – Rules of Play**

1. Tickets will be sold for 12 monthly prizes; the dates are as follows:

#### 2025 Calendar Year:

- a. Tickets sold November 1st 9am November 28th @ 9am
  - i. Draw November 28th @ 11am
- b. Tickets sold December 1st @ 9am December 23rd @ 9am
  - i. Draw December 23<sup>rd</sup> @ 11am

#### 2026 Calendar Year:

- c. Tickets sold January 1st @ 9am January 30th @ 9am
  - i. Draw January 30<sup>th</sup> @ 11am
- d. Tickets sold February 1st @ 9am February 27th @ 9am
  - i. Draw February 27<sup>th</sup> @ 11am
- e. Tickets sold March 1st @ 9am March 31st @ 9am
  - i. Draw March 31st @ 11am
- f. Tickets sold April 1st @ 9am April 30th @ 9am
  - i. Draw April 30th @ 11am
- g. Tickets sold May 1<sup>st</sup> @ 9am May 29<sup>th</sup> @ 9am
  - i. Draw May 29<sup>th</sup> @ 11am
- h. Tickets sold June 1 @ 9am June 30 @ 9am
  - i. Draw June 30 @ 11am
- i. Tickets sold July 1 @ 9am July 31 @ 9am
  - i. Draw June 31 @ 11am
- j. Tickets sold August 1 @ 9am August 31 @ 9am
  - i. Draw August 31 @ 11am
- k. Tickets sold September 1 @ 9am September 29 @ 9am
  - i. Draw September 29 @ 11am
- I. Tickets sold October 1 @ 9am October 30 @ 9am
  - i. Draw October 30 @ 11am

- 2. The winning number for the Monthly Draw Prize will be drawn on the last business day of the month at 11am at 1255 Old Derry Rd Mississauga ON (Virtual)
- 3. All Tickets will only be sold to people who are 18 years of age or older.
- 4. All tickets will be sold using an electronic raffle system provided by Raffle Nexus Canada Inc.
- 5. Must be in the Province of Ontario at the time of purchase.
- 6. Tickets are:
  - a. 5 tickets for \$10
  - b. 20 tickets for \$20
  - c. 50 tickets for \$50
- 7. Tickets will be available online

- 8. After purchasing tickets, patrons will receive a confirmation e-mail with their registered 50/50 ticket numbers. These numbers will be from a Random Selection System. No specific numbers can be given. All numbers are drawn at random.
- 9. The winning ticket(s) number will be selected using a Random Number Generator (RNG) system.
- 10. The cash amount of the 50/50 raffle will be available to see at any time during the raffle period at <a href="https://cvcfoundation.rafflenexus.com/">https://cvcfoundation.rafflenexus.com/</a>
- 11. The winner will be announced online at <a href="https://cvcfoundation.rafflenexus.com/">https://cvcfoundation.rafflenexus.com/</a>. The winner will also be contacted by a representative from the Credit Valley Conservation Foundation (CVCF) within 24 hours using the contact information provided at the point of purchase.
- 12. The winner may claim their prize by contacting Credit Valley Conservation Foundation at 905-670-1615 or by e-mail at <a href="mailto:foundation@cvc.ca">foundation@cvc.ca</a>. The winner will be paid by cheque or EFT for the amount posted on <a href="https://cvcfoundation.rafflenexus.com/">https://cvcfoundation.rafflenexus.com/</a>. Winners must present the original ticket and no copies.
- 13. The winning ticket holder has 6 months in which to claim their prize from the draw date listed on <a href="https://cvcfoundation.rafflenexus.com/">https://cvcfoundation.rafflenexus.com/</a>. There after the prize amount will be donated back to the support the mission of the Credit Valley Conservation Foundation.
- 14. The winner must provide their name, address, and phone number with picture identification for reporting.
- 15.Once the certified winner is verified and provides identification, they will be provided a cheque for the declared prize wish is at minimum 50% of the total sales of the draw. If the winner cannot provide photo ID, the prize will be held until photo ID can be provided.
- 16.In the event no winner comes forward and contact cannot be made, the winning ticket number will be held for 6 months. After that time period has

- passed, in accordance with the AGCO Lottery and Gaming 5.17.1 the prize will be used towards the mission programs operated by the Credit Valley Conservation Foundation with AGCO approval.

- 18.In order to purchase a ticket in the raffle, you must supply us with personal information including Name, home address, date of birth, payment card details and e-mail address. These details may be shared with Raffle Nexus Canada Inc. (Raffle Nexus) in order to process your request to purchase a raffle ticket. By purchasing a ticket, you consent to us sharing this information with Raffle Nexus and receiving future CVCF communications.

- 1. How much do tickets cost?

  5-Ticket Pack for \$10, 20-Ticket Pack for \$20, 50-Ticket Pack for \$50
- 2. Can I request a specific ticket number?

  No. Ticket numbers are computer-generated in ascending order starting at a pre-determined number.
- 3. When are the deadlines for ticket sales?
  Final Sales Deadline takes place every last day of the current month at 8:00 p.m.
- 4. What are the odds of winning?
  Actual odds depend on number of tickets sold.
